The Board is pleased to announce that all of the resolutions set out in the Notice were duly passed by the Shareholders by way of poll at the AGM held on 30 June 2023.

The Board would also like to announce that with effect from the conclusion of the AGM, Mr. Wong Man Li and Ms. Hui Wai Hing were re-elected as executive Directors, and Mr. Chau Shing Yim, David was re-elected as an independent non-executive Director.

Reference is made to the circular (the “**Circular**”) and the notice (the “**Notice**”) of annual general meeting (the “**AGM**”) of Man Wah Holdings Limited (the “**Company**”) both dated 1 June 2023. Unless otherwise specified, capitalised terms used herein have the same meanings ascribed to them in the Circular.
